








Instantaneous Forward Current - Amperes*versus* Instantaneous Forward Voltage - Volts



Average Forward Rectified Current - Amperes*versus* Lead Temperature -°C




Reverse Voltage - Volts






Peak Forward Surge Current - Amperesversus Number Of Cycles At 60Hz - Cycles




Peak Forward Surge Current - Amperesversus Pulse Duration - Milliseconds (mS)
