### F1 Typical Inductance vs. Current Characteristics:




### **F2 Typical Inductance vs. Frequency Characteristics:**

Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.


#### Product specific:
